Conditions for Adoption/Foster

HEAVENLEE'S RESCUE ADOPTION AGREEMENT (read all)

By signing this contract and agreeing to adopt an animal from HLR, the 'prospective family' agrees to and will abide by these terms and conditions, and they understand that if they do not, legal repercussions can and will be held against them.

1. Prospective owner will provide proper and exceptional care to the animal, which includes both physical and how you treat the animal emotionally. Owner will be required to always give animal access to proper and nutritional food, water, shelter, medical care, and behavioral care.

2. Prospect agrees that if the animal has not already been spayed or neutered, that they will sign a spay/neuter contract and will have veterinarian call HLR and let them know that the cat is being done on the registered day of the fixing.

3. If HLR decides that new owner is violating the terms and conditions of this contract, prospect agrees to let HLR seize back the animal to avoid the pursuit of the law, as charges WILL be filed.

a. If for ANY reason HLR believes that said animal is in unsafe conditions or care, you agree to the fact and understand that HLR can make 3 unannounced house visits at any time, in which you will be required to show the living conditions of the animal as well as the animal itself.

4. Prospect will acknowledge and understand that while in HLR possession, everything was done for the animal that we could do while he/she was in our care. Prospect also acknowledges that HLR cannot be held responsible for anything that happens to the animal medically after it leaves our care and cannot be held responsible or liable for any future veterinary or health-related fees.

a. This does not mean that we will not cover certain veterinary fees, but those will be on a case by case basis.

5. Prospect understands that once cat leaves HLR care, we can no longer control how the animal behaves. If cat behaves differently in new home, HLR is not held responsible. We are only able to control what happens to the animal while it is in our care.

6. Prospect acknowledges and understands that HLR can make no guarantee of health (aside from the animal's veterinary records) or behavior, and is not liable or responsible for any medical conditions that may flare up that HLR was not aware of. Prospect acknowledges and recognizes that they will be releasing HLR, its co-directors or any team members, and volunteers and employees from any and all claims relating to the animal or arising from the prospect's actions or inactions with the animal.

7. Prospect understands that if HLR finds evidence of animal abuse, legal charges can and will be filed against them upon contacting animal control and the state.

8. If for whatever reason the prospect cannot keep the cat (or animal) in their care and possession, that said animal will be returned to HLR before being given away or brought to a shelter.

9. Prospect agrees to all written terms that HLR has provided them and understands that HLR has the right to seize the animal should they violate the terms, or should HLR decide that they have violated the terms of adoption.
